The agriculture sector has benefited from the contribution of Renewable Fuel to the rise in commodity prices among other factors. Director Meister continued by adding that language be included to allow the "Executive Director is delegated to add language to this resolution consistent with the official positions of other Illinois agencies; we recommend that the Illinois Finance Authority Agriculture Committee position against USEPA's proposal be ratified by the full Illinois Finance Authority board at its next meeting."
