I. Call to Order and Roll Call

1B) Ronald Lee Beals - \$32,500 – 20 acres

Request for approval of the issuance of a Beginning Farmer Bond in an amount not-to-exceed \$32,500 for the purchase of approximately 20 acres of farmland. This project is located in Wade Township, Jasper County, IL.
