I. Call to Order and Roll Call

III. Project Discussions

Ms. Karcher presented the following projects to the Committee for review:

Beginning Farmer Bonds (One-Time Final Resolution)

1A) Ferguson, Austin D. & Kim A. – \$153,000 – 51 acres

Request for approval of the issuance of a Beginning Farmer Bond in an amount not-to-exceed \$153,000 for the purchase of approximately 51 acres of farmland. This project is located in Crooked Creek Township, Jasper County, IL.

1B) Vaughn, Tyler Ethan Ory - \$160,000 – 80 acres

Request for approval of the issuance of a Beginning Farmer Bond in an amount not-to-exceed \$160,000 for the purchase of approximately 80 acres of farmland. This project is located in Big Mound Township, Wayne County, IL.

1C) Robbins, Curt W. & Stacey R. - \$250,000 – 400 acres

Request for approval of the issuance of a Beginning Farmer Bond in an amount not-to-exceed \$250,000 for the purchase of approximately 40 acres of farmland. This project is located in Jasper Township, Wayne County, IL.

1D) McFarland, Gregory S. & Shyannon R. - \$215,600 – 98 acres

Request for approval of the issuance of a Beginning Farmer Bond in an amount not-to-exceed \$215,600 for the purchase of approximately 98 acres of farmland. This project is located in Flannigan Township, Hamilton County, IL.

1E) Muchow, Mason T. - \$246,783 – 41.15 acres

Request for approval of the issuance of a Beginning Farmer Bond in an amount not-to-exceed \$246,783 for the purchase of approximately 41.15 acres of farmland. This project is located in West Township, Effingham County, IL.

1F) Heiden, Cody - \$285,000 – 40 acres

Request for approval of the issuance of a Beginning Farmer Bond in an amount not-to-exceed \$285,000 for the purchase of approximately 40 acres of farmland. This project is located in Wheatland Township, Fayette County, IL.

Mr. Poole moved for approval of the above projects and Mr. Goetz seconded the motion. The motion was followed by unanimous approval of the Committee.

Mr. Frampton presented the following project to the Committee for approval:

2) Tyler and Candace J. Overton – Young Farmer Guarantee - \$193,000

Tyler and Candace J. Overton is requesting approval of a Young Farmer Guarantee (*Final One-Time Resolution*) in amount not-to-exceed \$193,000. The proposed loan of \$193,000 will finance a real estate loan for the purchase of 34 acres of farmland. Collateral will be a first mortgage on the 34 acres of land with an appraised value of \$391,000 (\$11,500 per acre) as of September 2013. This project is located in unincorporated Coles County, near Mattoon, IL.

Mr. Poole moved for approval of the above projects and Mr. Goetz seconded the motion. The motion was followed by unanimous approval of the Committee.
